IMPROVING OUR DEMOCRACY THROUGH ELECTORAL REFORM

In Canada's current electoral system, the majority of voters cast ballots for candidates that don't end up getting elected. This leaves people feeling disengaged with a process and result that doesn't accurately reflect their views.

Since 2015, the governing party has promised to make our democracy more reflective of voters' wishes hundreds of times, and yet nothing has changed.

As an opposition MP, I hope to

keep them accountable and have introduced Motion 76 calling for a citizens' assembly on electoral reform. Every vote should matter.

The motion has cross party support including from Liberal MPs who have jointly seconded this piece.

I will continue to push the governing party to fulfill this commitment, starting with this opportunity to give citizens a leadership role to ensure transparency and non-partisanship.

ADVOCATING ON AFFORDABILITY



Canada's Competition Bureau has been clear. A merger between two of the country's biggest telecommunications corporations would harm millions of consumers through higher prices, lower quality service, and less innovation for wireless services.

So in light of a proposed merger between Rogers and Shaw, I have written to the Honorable François-Philippe Champagne, Minister of Innovation, Science and Industry of Canada asking him to reject the proposed merger and to consider solutions that would better serve Canadians like a national cell service like some of our provinces have.

I've also written to Ministers advocating for them to:

- Improve travel document processing times
- Prohibit the building of new gas-fired power plants in Ontario
- Stabilize funding for local non-profits in our community
- Delay the MAID expansion to mental health until a proper review is completed on the impact of proposed changes, and alternative supports are offered (guaranteed income, housing, mental health)

SURVEY SAYS...


In my last mailing I asked what your top three issues are to help inform my advocacy in Ottawa.

It was sadly no surprise that housing continues to be a top concern, with mental health and the drug poisoning crisis next in line.

In addition to the categories provided, the most common topics respondents added under 'Other' related to improving long term care and healthcare, addressing wealth inequality between individuals and large corporations, and both meaningful climate action and protecting our natural spaces.

I truly appreciate that hundreds of you took the time to respond to let me know what's important to you.

One that's asking for Canada to give transgender and nonbinary people the right to claim asylum here has quickly become the most signed petition currently open with over 30,000 signatures!



LISTENING TO LOCAL AND NATIONAL VOICES

Thank you to all of the individuals and groups who took the time to meet with me, including:

- Canadian Mental Health
 Association and CMHA
 Waterloo Region in joint
 advocacy for mental health
 funding and the delay of the

- About 60 members of the local Syrian community to talk about how the federal government can best support earthquake relief efforts and bring family members to safety

- Local arts organizations followed by a meeting with Minister of Canadian Heritage Pablo Rodriguez to request funding to support pandemic recovery

- Newly elected and re-elected members of municipal government to discuss how we can work together to serve Kitchener Centre and Waterloo Region as a whole

STRENGTHENING THE CANADA DISABILITY BENEFIT



In October this past year, I sponsored a Parliamentary Reception with national advocates from Disability Without Poverty, and spoke at their rally in Ottawa (pictured above). Our advocacy worked! That same week the Canada Disability Benefit Act passed second reading.

After more than a year of advocating for the federal government to fast-track the Canada Disability Benefit, I was honoured to secure support for five of my amendments to the bill that will provide a guaranteed income for Canadians with disabilities.

Every amendment I proposed came directly from disability advocates in Kitchener and across the country. I'm thrilled so many of them were supported and will now be included as part of much stronger legislation.

Among the amendments I proposed, the committee accepted:

- To include a definition for the term 'disability' to ensure consistent and equitable access and eligibility
- A requirement for the federal government to make the agreements they sign with the provinces and territories public
- Direction for those who write the regulations to require the benefit to be indexed to inflation
- For the benefit to be barrier-free, meaning recipients shouldn't have to complete a cumbersome application to be eligible and could include a potential recipient being automatically enrolled when completing their income taxes
- For people with disabilities to have meaningful and barrier-free opportunities to give input into regulations as they're developed

I had also hoped to see the adoption of an amendment that would have removed the working age caveat so that seniors with disabilities would be able to access the benefit. I am now working with Senators as the bill passes through their hands to continue to improve this bill, and am calling for the governing party to include funds for the Canada Disability Benefit in Budget 2023.



It was incredible to be part of my first in-person citizenship ceremony last month. I look forward to seeing the dreams of the 23 new Canadians from 12 countries come to fruition.

The Minister was candid and receptive to the great ideas we heard and I also appreciate my colleague MP Val Bradford joining us for this important conversation.


